It does not include residential assistance, only municipalities, fire departments, hospitals, etc. We are reporting all of the costs that we expended including our regular and overtime for our public works department and all of the losses within our building. MAYOR, PASQUALE DEBLASIO

POLICE CHIEF, CHAD KING

Chief King stated that December was a pretty busy month with 32 criminal arrests and 54 charges that were filed. For the year there were 228 criminal arrests, 410 criminal charges and 537 traffic tickets issued. There were 2,841 calls for service answered. For the 8th year in a row, we received the Triple A Community Traffic Safety Award for educational programing to protect citizens and improve safety within the Borough.

ENGINEER, JOE SITES

Engineer Sites thanked Council for his appointment and he is looking forward to working with Council in the upcoming year.

2013 Pavement Maintenance Program - Contract A - Baldwin Street

Work on Baldwin Street will be completed by Youngblood Paving in the spring of 2014 since Baldwin Street was the detour for Bower Hill Road. They will be holding their prices as bid.

2014 Pavement Maintenance Program

We would like to meet with the Public Works Committee over the next month to identify potential roads to be considered for the 2014 Pavement Maintenance Program so that we can get the project out for bid in March or sooner.

Sanitary Sewer Repairs - Operation and Maintenance - 2013 Project

Insight Pipe Inc. has completed all of the repairs and we are in the process of finalizing quantities for work completed to date so that the project can be closed out. We anticipate a finalizing of the project for the February Council meeting.

Rear of New York Street Sanitary Sewer Improvements

We have reviewed the video inspection of the sanitary sewer at the rear of New York Street and are in the process of completing our research of the easements and want to meet with the property owner where the repair is needed. Currently a sag exists in the line that is slowing down the flow. Upon our meeting with the property owner we will have a better idea of the method and route that we want to take to complete the repair since there are trees and a retaining wall constructed over the sanitary sewer.

Street Opening Permit – St. Clair Street

The transfer of all of the residential services and restoration on St. Clair Street need to be completed. Once the services are transferred, the pavement restoration can be completed by the water company.

GIS Mapping, Signs and Fire Hydrants

We have met with the manager to discuss the Borough GIS Mapping updates, sign inventory and fire hydrant mapping. We have developed scopes and some budget amounts for consideration to proceed with the projects to address regulatory requirements.

850/861 McLaughlin Run Road Wall - DEP Bureau of Mine Reclamation

All of the work has been completed except for the landscaping.

FIRE CHIEF, WILLIAM CHILLEO

Fire Chief Chilleo stated that last year was very busy. They ended the year with 295 calls. There were 11 structure fires between our town and other towns.

Mutual Aid included 43 calls with Upper St. Clair, Fairview, Presto, Carnegie, Mt. Lebanon and Bower Hill. The largest amount of calls we had were the flooding that occurred on July 10th with 121 calls for service.

He also stated that the Luminary Sales went very well and they will be selling them again next year. With the cold weather conditions, the Fire Station will be set up as a warming station for tonight and tomorrow night in case someone loses power or needs a place to stay warm.

SOUTHBRIDGE EMS, DAN MILLER

Absent, but he wanted Fire Chief Chilleo to advise everyone that SouthBridge EMS is also ready to assist with the cold weather.

LIBRARY DELEGATE, MICHAEL AQUILINA

BOROUGH MANAGER, LORI COLLINS

Manager Collins stated that we are busy with the year-end close out of 2013 and the opening of 2014. Today Jordan Tax did their first sanitary sewer billing for us. There is notification on the bills stating that they will be taking over the billing as of January 1st. If residents have any questions, they can contact Jordan Tax or the Borough office. There is an extension at Jordan Tax that will handle Bridgeville exclusively. Payments may still be made at the Borough office. They will be forwarded to Jordan.

She also stated that information for the warming station has been placed on the website's main page.
