# PROPOSED ORDINANCE NO. 981

Ghelarducci approving Solicitor McDermott to prepare Proposed Ordinance No. 981 and Manager Collins to advertise the same; an ordinance amending the current rates charged for sewer service within the Borough of Bridgeville with the Allegheny County Sanitary Authority increase of an additional \$.56 per 1,000 gallons of water usage and a \$1.19 per quarterly bill increase of the service charge.
